

### Accommodation in Glasgow

The Conservatoire has two sites within a ten-minute walk of each other. Our Renfrew Street site is located at **100 Renfrew Street, Glasgow G2 3DB** and Wallace Studios are situated at **210 Garscube Road, Glasgow, G4 9RR**.

The Conservatoire's recommended student accommodation is **BASE Glasgow**, managed by <u>Here!</u> Should you wish to secure a room somewhere other than in BASE Glasgow the following information may help you.

# Purpose Built Student Accommodation (PBSAs)

There are several privately-run, purpose-built Student Accommodation residences in the city centre. Base Glasgow is one of them, with the Conservatoire reserving a quota of rooms each year for its students. All new Conservatoire students are encouraged to rent a room in <u>Base Glasgow</u> but those students who do not wish to or may not want to, might need to look elsewhere.

The residences listed above are owned by private companies and are not affiliated to any higher education institution. They are open to students from across the city, regardless of institution. The Conservatoire is not able to recommend any of them; it would be your free choice to decide whether you wanted to make a booking with one of them.

Things to consider when renting a room in a PBSA residence:

- The proximity to the Conservatoire
- The length of contract
- The cost of the full length of the contract, not just the weekly price
- What happens if you were to withdraw from your course? Would you still be liable to pay the rent until the end of the contract period
- What support is available? Is there an on-site staff member and/or security guard? Many PBSA residences have 24 hour CCTV and a secure entry door but will not have a member of staff on-site round the clock.
- You do not need to complete the online form for student council tax exemption, as students living in PBSAs will automatically receive Council Tax Exemption.

Some of the above-mentioned PBSAs will allow students to pay in instalments but will require you to have a UK guarantor. This may be difficult for international students and



unfortunately, the Conservatoire cannot act as guarantor in this instance. There are some companies, which, for a fee, will act as a UK guarantor for international students. One such company is <u>Housing Hand</u> but others such as <u>https://www.rentguarantor.com/</u> and <u>https://ukguarantor.com/</u> are available.

The <u>Social Hub</u> offers a diverse range of facilities and alongside hotel rooms and meeting and events spaces, they also offer all-inclusive accommodation offering a range of check-in and check-out dates for short term or extended stays.

### Renting a room in a flat/house

Glasgow has a large amount of accommodation suitable for students who do not wish to stay in a PBSA residence. The main ways to find a room are as follows:

- 1. Use a **local letting agent**. There are many letting agents that rent out properties suitable for students. They can be found by using one of the many listings websites such as <u>www.yell.com</u>
- 2. Use a website portal that features properties to rent from other sources:

- Use word of mouth via the RCS Freshers Facebook page. This is a useful way to find a flatmate and some current RCS students advertise spare rooms this way. The following group on Facebook may also be helpful to join: <u>Glasgow Student</u> <u>Accommodation</u>
- 4. If you are willing and able to offer a specified number of weekly hours of help and support to an older person in exchange for a low-cost room in their house, you might want to explore the Share and Care Homeshare scheme. # Hints and tips on renting a room/flat

### Before moving in:

- You should only rent a property from an accredited landlord or letting agency. Accredited landlords have agreed to abide by a set of standards (or code) relating to the management and physical condition of their property.
- In Glasgow, all landlords letting properties must be registered with Glasgow City Council, unless they are just letting a room in their own home. Check on the Landlord Registration Scotland website or call them on 0300 343 0414.
- Some people use websites to advertise properties which do not exist and take money illegally so please always make sure the landlord is registered.
- Ensure that you have read and understood the lease agreement before signing.
- There is usually a deposit to pay, which is normally one month's rent. This is to cover any damages or unpaid bills at the end of the tenancy and will be returned in full at the end of the tenancy, as long as there are no damages or unpaid bills. Make sure you receive a receipt for any deposits paid. Your landlord or letting agent must transfer your deposit to a government-approved scheme, like <u>SafeDeposits Scotland</u>, to keep it safe. This is the law in Scotland.

### When you move in:

- You must take the gas and electricity meter readings immediately. Ensure that new accounts for gas, electricity, telephone etc. are set up in your name.
- Ensure that any damage is reported in writing and keep a copy of all letters.
- Make sure that you have proof of payment for all rent paid.
- Make sure you get contents insurance for your possessions. The landlord will be insured for the contents that come with the flat but this will not cover your possessions.
- If you are a full-time student, you should complete the online <u>Council Tax student</u> <u>exemption form</u>. Please see the section called <u>What is Council Tax?</u>

### How to find a room-mate

You might find a property which will require you to share with others. Finding another student to share with isn't usually a problem for continuing students, but it can be an issue for those who are just starting their studies at the Conservatoire. Our Facebook Freshers'



page is an excellent way to find someone to share a flat with in Glasgow. You will be sent an email with the link to the group from our Admissions team.

### **Accommodation for families**

If you're bringing family with you while you study at the Conservatoire it would be advisable to rent a private flat using a local letting agency. The PBSAs in the city, including Base Glasgow, do not offer accommodation for families.

#### **Inbound Exchange students**

If you're only going to be at the Conservatoire for a short period of time you might find it a little bit more difficult to find accommodation in Glasgow. Base Glasgow may be able to offer short-term contracts subject to availability.

Some of the other PBSAs do not offer contracts for less than a full academic year but some will offer short-term contracts, and you should check on their websites. <u>The Social Hub</u> may be a suitable option for you to investigate.

#### Temporary accommodation on arrival in Glasgow

If you cannot find accommodation in advance of your arrival in Glasgow, you may need to secure short-term accommodation in the interim. You will be able to find hotels, hostels and Bed and Breakfast accommodation in the city at <a href="https://www.visitscotland.com/">https://www.visitscotland.com/</a>

## What is Council Tax?

- Council Tax is a tax levied on households by local authorities in the UK, based on the estimated value of a property and the number of people living in it. Students are not required to pay council tax if they are enrolled on a full-time course of 21 hours or more per week for a minimum of 24 weeks per year but they must apply for a student exemption. Students living within the Glasgow City Council area need to complete an online <u>Council Tax Student Exemption form</u> This can only be done after matriculation and after the start of Term 1 on 22nd September 2025. After matriculation, the Conservatoire will confirm student status electronically to Glasgow City Council, unless a student has opted out of the data sharing agreement at matriculation. In such a case the student will need to make their own arrangements. Students living in PBSAs in Glasgow (also referred to as independent student halls of residences) do not need to complete the online form as they will automatically receive Council Tax Exemption.
- Full-time students are only exempt from council tax from the date their course starts until the date their course ends, not their graduation date.
- Students living outside of Glasgow should find the *Council Tax Student Exemption form* on their local council website. After completing Section 1, students should take the form to the Student Records team located in the Academic Administration and Support office (ground floor of the Renfrew St building).
- If you are a student from elsewhere in the EU, you may still be regarded as a student for Council Tax purposes. Remember, you must fulfil the same criteria as UK students for Council Tax. This means that you must be registered and attend a designated educational establishment and undertaking a course which leads to the award of a relevant qualification by that establishment. Any non-student spouses or adult dependents who live with you may remain liable to pay Council Tax.
- Students on short-term Erasmus+ or International Exchange study should follow the instructions as listed above. If you are not living in a PBSA you will also need to submit a letter from your home institution confirming the details of your home programme (e.g. programme title, duration etc.) and that you are currently on an exchange at the Conservatoire.
- If a student is living with someone who is not a student, then the student will still be exempt from Council Tax but the non-student will have to pay. A discount may be awarded but this is based on the full household circumstances and is subject to review from the council concerned. Please speak to a member of the Council Tax team at your local council.
